

Mile High United Way's Suncor Energy Fuel Giveaway Rules

The Prize

Mile High United Way is giving away five sets of Suncor Energy fuel certificates to individual donors. Each has a value of \$2,000. One Suncor Energy Fuel Certificate Set will be awarded to each of the five randomly selected winners. The certificates can be used at all participating Phillips 66 or ConocoPhillips branded stations. Fuel certificates will be provided as \$10 denominations in books of \$50. These certificates can be used to purchase gasoline, car washes, and convenience store items within each participating store. Purchase is necessary in order to use each certificate. Change will be given at time of purchase. No change will be given for certificates that are not necessary to pay for a purchase. For example, if an individual makes a purchase of \$15.00 and presents three \$10.00 certificates, the individual will receive \$5.00 in change and be returned one \$10.00 certificate. Fuel Certificates cannot be exchanged for money.

Who is eligible?

Any U.S. resident who is 18 years or older and who makes a donation to Mile High United Way for the 2009-2010 campaign. (July 1, 2009 through April 9, 2010)

Who is not eligible?

Mile High United Way staff, board members and their immediate families as well as employees of Suncor Energy and their immediate families are not eligible to win Suncor Energy fuel certificates. Businesses making a donation to Mile High United Way are not eligible to win Suncor Energy fuel certificates.

How the drawing works.

Your individual donation is your entry into the Fuel Certificate Giveaway. Winners will be randomly selected from all entries as detailed below. Two winners will be randomly selected and announced on Friday, December 11, 2009 and three winners will be randomly selected and announced on Friday, April 16, 2010. All winners will be notified by phone on the same day as the drawing. Winners will be allowed ten days to respond, at which time, they must verify their eligibility. After eligibility is verified, Suncor Energy Fuel Certificate sets will be mailed to winners via certified mail. In the case of ineligibility or prize refusal, an alternate winner will be drawn.

Timeframe and Drawings

1. To be entered in the December 11, 2009 drawing, donations to Mile High United Way must be received after July 1, 2009 but before December 4, 2009.
2. To be entered in the April 16, 2010 drawing donations to Mile High United Way must be received after July 1, 2009 but before April 9, 2010. (Winners of the December 11th drawing will be excluded from the April 16th drawing.)

Requirements

To be eligible to win a Suncor Energy Fuel Certificate Set all personal contact information must be provided at the time of donation, this includes: name, home address, personal phone number and personal email address.

For tax purposes, winners of the Suncor Energy Fuel Certificate Set are required to provide Mile High United Way with their personal contact information and their social security number. It is the responsibility of the winner to pay all applicable taxes related to the transaction. Mile High United Way will provide a 1099 form to each winner by January 31st of the following tax year the fuel certificates are awarded. No cash equivalent will be given in lieu of the fuel certificates. Prizes are non-transferable. Odds of winning any prize depend upon the number of eligible entries in the Sweepstakes.

The winners of the Fuel Certificate Giveaway grant Mile High United Way and Suncor Energy the use of their names and photographs in communication and publicity materials.
